

**Official Rules – B93.3 KBLB Today’s Best Country
Facebook Comment Sweepstakes**

**NO PURCHASE NECESSARY.
PURCHASE WILL NOT IMPROVE CHANCES OF WINNING**

1. **When to Enter:** You may enter the B93.3 KBLB Today’s Best Country Facebook Comment Sweepstakes (“Sweepstakes”) from the dates and times listed on the Sweepstakes post (“Sweepstakes Post”) on Facebook (“Sweepstakes Period”).
2. **How to Enter:** To enter, visit the B93.3 KBLB Today’s Best Country page on Facebook (“Website”) during each Sweepstakes Period, and **comment** on the by answering the question or providing a reply to the Sweepstakes Post to receive one (1) automatic entry into the Random Drawing.

All comments must be posted by the end date and time as specifically listed in the Sweepstakes Post to be entered into the Random Drawing. **Limit:** one (1) entry per person/email address. Anyone attempting to get more than one (1) entry may be disqualified from the entire Sweepstakes at Sponsor’s sole discretion.

This Sweepstakes is not sponsored, endorsed, administered by or associated with Facebook. By entering, you are providing your information to Sponsor and not to Facebook.

3. **Random Drawing:** A random drawing will be conducted on or about the business day immediately following the end date of the Sweepstakes Period and will be from among all eligible entries received. Decisions of judges are final and binding. Odds of winning depend on the number of entries received. Sponsor will conduct the random drawing. Winner will be notified by direct message or by commenting on the Sweepstakes Post with the winner’s name, on or about the date of the drawing. Sponsor will make up to **2 attempts** to contact the winner. Winner will have twenty-four (24) hours to respond to the winner notification. If the winner cannot be contacted after 2 attempts, or does not respond to a winner notification within 24 hours, that potential winner will forfeit the prize, and the prize may be awarded to an alternate winner, time permitting. Sponsor is not responsible for direct messages that go unread or are undelivered due to a technical error out of Sponsor’s control, or for another failure of potential winner to see the winner notification in time.
4. **Claiming Your Prize:** Upon winner verification, the winners will either, as determined solely by Sponsor, be told how they will receive their prize in one of two ways as follows: (1) **Prize Pick-Up:** **as a condition of being named an official winner**, each potential winner must claim his/her prize in person at B93.3 Studios located at 13225 Dogwood Drive South, Baxter, MN 56425, during normal business hours (Monday-Friday, 9:00 a.m. to 5:00 p.m.) within **ten (10) business days** of the day he or she wins to verify that he/she is the qualified winner and must sign a Publicity and Liability Release (“Release”) upon (and as a condition of) picking up the Prize. Failure to comply with this deadline shall be deemed to be the winner’s forfeiture of his or her right to claim the Prize. The winner must prove he or she is a qualified winner by presenting acceptable identification (e.g., state driver’s license; state issued identification card; valid passport with address verification; or birth

certificate with social security card and photo identification and address verification). If a winner cannot prove he or she is a qualified winner, the prize will not be awarded. OR (2) Prize Mailed: Sponsor will mail out the prize to the winner. Sponsor is not responsible for lost, late, mutilated, damaged or delayed mailing of any prizes. All unclaimed or returned prizes remain the property of Sponsor.

5. **Prizes & Approximate Retail Values ("ARV"):** The specific prize(s) and ARV of each prize available to be won in each Sweepstakes will be as specifically listed in the Sweepstakes Prize Details page. Prizes consist of only those items specifically listed as part of the prize. Taxes are winner's sole responsibility. Prizes are not transferrable, substitutable, and may not be redeemed for cash. Sponsor reserves the right to substitute any prize, or portion thereof, for any reason at Sponsor's sole discretion. Any limitations on any prize will be provided at the time the prize is awarded.

The winners must meet the eligibility requirements as set forth in Paragraph 6 of these Official Rules. Winners may be required to sign a liability and/or publicity release ("Prize Release") prior to issuance of a prize. Sponsor may substitute any prize, or portion thereof, for one of equal or greater value for any or no reason at Sponsor's sole discretion.

7. **Entry Conditions and Release:** By entering, each entrant agrees to: (a) comply with and be bound by these Official Rules and the decisions of the Sponsor which are binding and final in all matters relating to this Sweepstakes; (b) release and hold harmless the Released Parties and Facebook from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a participant's entry, creation of an entry or submission of an entry, participation in the Sweepstakes, acceptance or use or misuse of prize and/or the broadcast, exploitation or use of entry; and (c) indemnify, defend and hold harmless the Released Parties and Facebook from and against any and all claims, expenses, and liabilities (including reasonable attorney's fees) arising out of or relating to an entrant's participation in the Sweepstakes and/or entrant's acceptance, use or misuse of Prize.

9. **General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, for any reason whatsoever, including, without limitation, fire, flood, natural or man-made epidemic of health of other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction or if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. If the Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select the Prize Winners in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Only the type and quantity of prizes described in these Official Rules will be awarded. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
10. **Limitations of Liability:** The Released Parties, as set forth above, and Facebook, are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any Prize.
